# ACCESS

The application, to comply with all the security constraints used by our Trustee, once you click on log in will request the mandate's number.

#### PRIMO ACCESSO

The system will be able, if it is the first time that the new Reserved Area is accessed, to verify the effective authorization and in this case to send the temporary credentials to be used for the first access to the email address provided.

Still in the field of protection ... if there is no response, or if there is no open mandate with shares in position, the application will promptly report it thanks to a very intuitive message. There is also the case of a real correspondence of the data but associated with a position that is now closed ... also in this case the application will adequately inform the user.



# **TEMPORARY CREDENTIALS**

The system will send an email to the address provided and associated with the personal data with the credentials to access.

Once received, simply click on the relevant button and log in.

At the top right there is the area dedicated to your profile from where you can manage some important operations.	Among some shareholders of Azimut Holding S.p.a. on July 7, 2004, a voting and blocking syndicate was set up which can be joined by managers, employee, collaborators and financial advisors belonging to the "Azimut Group" Ineaning the Company and its subsidiaries and / or associates pursuant to Arctice 2393 of the Italian Chil Codel (the Agreement). The shares conferred in the agreement are conferred by each member in a fiduciary mandate signed with Timone Fiduciaria S.r.L and are deposited with AZIMUT CAPITAL MANAGEMENT SGR 5.p.A., which in turn has deposited them with Banco BPM 5.p.A.
CHANGE PASSWORD	

It is highly recommended, if it is the first access, to change the temporary credentials provided by the application.

In this case it will be enough:

1. find the temporary password from the email and enter it in the Current Password field

2. and finally choose the new one to keep carefully.

the application will require during access. Let's see how it works ... the first thing to do is to enable this functionality, thanks to the relative button. The system will ask for confirmation of your password before proceeding.

Once provided, a QR code will be generated. Now, based on the type of Device (iPhone, iPad, SmartPhone, etc.) you will have to create the association to the Token with your Account. To do this, an application is required:

For Apple Device, Authenticator present at this address is recommended: https://apps.apple.com/it/app/authenticator/id766157276

While for Android we recommend Google Authenticator present at this address: <u>https://apps.apple.com/it/app/google-</u> <u>authenticator/id388497605</u>



Once the application is available on your phone, just scan

the QR code and from this moment the association will come into operation every time you log in.

From this moment, to access your private area:

- 1. You will need to provide your credentials
- 2. You will have to provide the code present in the downloaded application

Another very important thing are the codes that the application has provided us with the QR code. These are of vital importance if the phone is lost or the latter is no longer available. If one of the situations described above occurs, these codes would still allow you to access and correctly reassociate your devices.

# EQUITY FINANCIAL INSTRUMENT
